follows:-Section 2 of the Official Secrets Act, 1911, as amended by the Official Secrets Act, 1920, provides as

- any sketch, plan, model, article, note, document, or information which relates to or is used in a prohibited place or anything in such a place, or which has been made or obtained in contravention of this Act or which has been entrusted in confidence to him by any person holding office under Her Majesty or which he has obtained or to which he has had access owing to his position as a person who holds or has held a contract made on behalf of Her Majesty, or as a person who is or has been employed under a person who holds or has held such an office or contract:— "2(1)-If any person having in his possession or control any secret official code word or pass word or
- communicates the code word, pass word, sketch, plan, model, article, note, document, or information y person other than a person to whom he is authorized to communicate it, or a person to whom in the interests of the State his duty to communicate it; or
- prejudicial to the safety or interests of the State; or the information in his possession for the benefit of any foreign power or in any other manner
- retains the sketch, plan, model, article, note or document in his possession or control when he has no right to retain it or when it is contrary to his duty to retain it or fails to comply with all directions by lawful authority with regard to the return or disposal thereof; or
- fails to take reasonable care of, or so conducts himself to endanger the safety of the sketch, plan article, note, document, secret official code or pass word, or information;

that person shall be guilty of a misdemeanour.

- or information which relates to munitions of war, communicates it directly or indirectly to any foreign power or in any other manner prejudicial to the safety or interests of the State, that person shall be guilty of a (1A) If any person having in his possession or control any sketch, plan, model, article, note, document,
- (2) If any person receives any secret official code word or pass word or sketch, plan, model, article, note, document, or information, knowing or having reasonable ground to believe, at the time when he receives it, that the code word, pass word, sketch, plan, model, article, note, document, or information is communicated to him in contravention of this Act, he shall be guilty of a misdemeanour, unless he proves that the communication to him of the code word, pass word, sketch, plan, model, article, note, document, or information was to his desire."

1 (2) of the Official Secrets Act, 1920, provides as follows:-

- "(2) If any person-
- (a) retains for any purpose prejudicial to the safety or interests of the State any official document, whether or not completed or issued for use, when he has no right to retain it, or when it is contrary to his duty to retain it, or fails to comply with any directions issued by any Government Department or any person authorized by such department with regard to the return or disposal
- **E** allows any other person to have possession of any official document issued for his use alone or authority by whom or for whose use it was issued, or to a police constable; or of any official document by finding or otherwise, neglects or fails to restore it to the person or pass word issued for the use of some person other than himself, or on obtaining possession authority or excuse. communicates any secret official code ny secret official code word or pass word so issued, or, without lawful has in his possession any official document or secret official code word
- (c) without lawful authority or excuse, manufactures or sells, or has in his possession for sale any such die, seal or stamp as aforesaid

he shall be guilty of a misdemeanour."
