JOB PURPOSE

To coordinate and monitor development and strengthening of infant and young child feeding programme as well as monitoring the implementation of the Baby-Friendly Hospital Initiative islandwide

KEY RESPONSIBILITY AREAS

Breast Feeding - Parish level

- 1. Supervise the establishment of Breastfeeding Clinics and execution of needs assessments for each health centre
- 2. Develop and monitor implementation of policy for Infant and Young Child Feeding
- 3. Train health workers to operate Breastfeeding clinics
- 4. Coordinate training for Baby Friendly Hospital Initiative
- 5. Coordinate training for Breastfeeding Support Group volunteers in all parishes
- 6. Coordinate training in Infant and Young Child Feeding principles and practices across all sectors
- 7. Coordinate training for Infant and Young Child Feeding components in CHA Home-visiting Programme
- 8. Coordinate training for EC practitioners (i.e. Day Care Centre/Nursery & Basic School staff)
- 9. Coordinate community mobilization sessions (Breastfeeding and Infant and Young Child Feeding promotion for doctors via Professional Associations, collaboration with Ministry of Labour re policies and breastfeeding support in workplaces).

- 10. Develop and/or supervise material development and production, as indicated below:
 - Posters
 - Job aides
 - Drama-based video (drawing from evaluation data)
 - Supervision checklist
 - Brochure for parents
 - Brochure for EC practitioners
- 11. Identify resources needed for programme (i.e. TV/VCRs, fridges, couches, filing cabinets, fans, garbage bins, photocopiers, flip charts for BF clinics, incentives for volunteers) as needed.
- 12. Support evaluation processes.

- 13. Coordinate Infant and Young Child Feeding Committee
- 14. Coordinate sensitization sessions on The National Infant Feeding Policy and Strategic Plan for Breast Feeding
- 15. Co-ordinate Baby-Friendly hospital initiative (BFHI) in hospitals
- 16. Coordinate training in Infant and Young Child feeding training including training for BF Support Groups
- 17. Coordinate Breast feeding Week Activities
- 18. Collaborate with the Health Promotion and Education Unit to develop educational material including the drafting of messages for mass media public education and information campaign

Infant and young child feeding activities

- 19. Revise and develop educational material for complementary and young child feeding
- Coordinate Nutrition Education programmes for caregivers in Children's Home, Health Staff and Early Childhood Institution Practitioners in collaboration with the Child Development Agency
- 21. Promote adequate nutrition in all settings where the Infant and Young Child are facilitated

22. Any other related activities assigned by the Director, Nutrition
