- Maintaining personnel records for staff.
- Arranging leave and allocating replacement from within the department or liaising with the HR department for outside replacements.
- Ensuring maintenance of quality and safety practices.
- Ensuring maintenance of imaging equipment,
- Liaising with radiologists re imaging policies and procedures.
- Maintaining departmental records and submitting statistics accordingly.
