To provide direction and management of the Food Safety Programme of the Environmental Health Unit and to ensure that the nation's food is safe for human consumption.

# **KEY RESPONSIBILITY AREAS**

### A. Management and Administrative

- 1. Formulates a National Food Safety Policy and develops programmes to ensure that the national food supply is safe for human consumption.
- 2. Provides technical advice on food safety issues.
- 3. Represents the Ministry at regional and international conferences and symposia on food safety
- 4. Participates in the development of the operational plans and budget for the Environmental Health Section.
- 5. Prepares and submit reports

# **B. Technical**

- 6. Develops and guides the implementation of systems in order to enhance food safety.
- 7. Interprets regional and international agreements and regulations for the national food safety programme.
- 8. Guides inter-sectoral cooperation between the Ministry of Health and the industry on food safety matters.
- 9. Monitors the activities of the Regions in the implementation of food safety programmes and provides the Directors, Environmental Health

with reports/ updates

- 10. Collaborates with the Standards and Regulation Branch in developing norms and protocols for licensing, inspecting and certifying food service establishments.
- 11. Develops criteria for classifying food handling establishments based on the dangers they pose to food safety.
- 12. Interfaces with Consultants to the Ministry on food safety matters and provides technical reviews of reports submitted by them.
- 13. Recommends policies and guidelines regulating the importation of foods.

### C. Human Resource Management

- 14. Identifies training needs for the industry and assists with the development of a model food safety training programme for the hospitality sector and the wider food-handling industry.
- 15. Develops a programme for the accreditation of trainers in food safety.
- 16. Designs/reviews the health certification programme for food handlers.

### D. Other

17. Performs other related duties and responsibilities as may be determined by the Ministry of Health from time to time.
