JOB PURPOSE

To monitor the trends in prevalence of HIV/AIDS in the Jamaican population, providing data to: Evaluate the impact of the National HIV/STI programme's preventive activities Guide future programmes and interventions Measure the burden of HIV/AIDS

KEY OUTPUTS

- 1. Annual sero-surveys conducted among the ANC and STI clinic attendees.
- 2. Survey reports documenting trends in prevalence rate of antenatal and STI clinic attendees
- 3. Quarterly sero-prevalence reports for selected population groups, disaggregated by gender, age and group.
- 4. National AIDS Summary reports generated quarterly.
- 5. Data collected from major public hospitals and other places such as hospices.
- 6. Timely dissemination of reports for field investigation.
- 7. Alleged transfusion investigation report prepared

KEY RESPONSIBILITY AREAS

- 1. Plans, co-ordinates, HIV sero-survey among antenatal, sexually transmitted infection clinic attendees and other selected groups. Collates/analyzes data and prepares reports.
- 2. Collects, collates, analyzes HIV data from selected population groups and prepares reports.
- 3. Active surveillance of major hospitals and other places such as hospices collecting data, to ensure completing reporting of HIV/AIDS cases to the Ministry.
- 4. Verifies and validates all individual HIV/AIDS reports submitted to the Ministry from private and public sector islandwide, by checking each form and ensuring readiness for data entry.

- 5. Carries out timely dissemination of HIV/AIDS data to field staff for investigation
- 6. Participates in special surveys/investigations as required.
- 7. Carries out investigations and prepares reports for cases of alleged HIV infection through blood transfusion.
- 8. Performs any other related duties as assigned by Medical Surveillance Officer/ Executive Director, National HIV/STI Prevention and Control Programme.

PERFORMANCE STANDARDS

- 1. Reports generated are accurate and delivered on a timely basis
- 2. Confidential information obtained on the job is preserved
- 3. Quality checks on field data are carried out frequently
- 4. Medical Surveillance Officer is advised promptly of changes in epidemiologic trends.
