JOB PURPOSE

Administer the Dangerous Drug Act 1948 and Dangerous Drug Regulation 1948. Administer the Food and Drugs Act 1964 and Regulation 1975. Administer the Precursor Chemical Act 1999. Annual & Quarterly Reports to the international Narcotics Control Board.

KEY RESPONSIBILITY AREAS

Management/Administrative Responsibilities

- 1. Coordinates the activities of the unit responsible for Dangerous Drugs, Psychotropic and Precursor Chemicals
- 2. Represent the Ministry at meetings, National and International Conferences and other functions as requested
- 3. Provides guidance on matters related to narcotics, psychotropic and precursor chemicals
- 4. Assist with maintaining in house records which will be required as part of a base for providing current information for interest groups
- 5. Prepares and monitors the department, work plan and ensures that targets are met.

Technical/Professional Responsibilities

- Assess and approve applications for the importation of narcotics, psychotropic and precursor chemicals
- 7. Assess invoices to verify that information is in accordance with permit granted for narcotic, psychotropic and precursors chemicals.
- 8. Issue licence for local purchase of narcotic substances.
- Narcotic audits of hospitals, pharmacies and doctor's office.
- 10.Inspection of distributors, pharmacies with regards to psychotropic and narcotic drugs.
- 11. Good manufacturing Practice inspections of companies with regards to importation and distribution of precursor chemicals
- 12. Good manufacturing Practice inspections at pharmacies, pharmaceutical manufacturers and distributors companies
- 13. Training of nurses with regards to dangerous drug
- 14. Grant permission to overseas visitors to bring their dangerous drugs medication with them
- 15 Authorisation of pharmacists, veterinary practitioners and medical doctors to handle dangerous drugs
- 16. Conduct periodic research relevant to functions as required
- 17. Perform any other activity as designated by Directors in the Standard and Regulation Division

Human Resources Responsibilities

- 18. Provide guidance to staff through coaching, mentoring and training providing assistance and support as needed
- 19. Participate in the recruitment of staff for the department
- 20. Ensures that staff is aware of and adheres to the policies, procedures and of regulations of the division and the Ministry of Health

PERFORMANCE STANDARDS

- 1. Maintain turn around time of approval at 80% if daily incoming applications
- 2. Submit Monthly reports due at the ending of each month
- 3. Submit Quarterly report due during first month of each quarter
- 4. Annual report due at the end of January of the New Year
- 5. Answer queries and provide information on the processing and regulations governing importation of narcotic, psychotropic and precursor chemicals

SPECIAL CONDITIONS ASSOCIATED WITH THE JOB

Typical working environment, no adverse working conditions

<u>AUTHORITY</u>

- To inspect pharmacies, pharmaceutical distributors and pharmaceutical manufacturers
- To inspect companies which import and distribute precursor chemicals
- To stamp and sign approvals for importation of narcotics, psychotropic and precursor chemicals
- To stamp and sign refusals for importation of narcotics, psychotropic and precursor chemicals on behalf of the Minister of Health
- To detain and/or seize any narcotic, psychotropic precursor chemicals deemed illegal by the Chief Dangerous Drug Inspector
